
**Penalty Infringement Notice



**Important Please Note:-**

If you do not undertake one of the below options, enforcement action may be taken to recover the amount, including by registering it with the State Penalties Enforcement Registry, and additional fees may be payable.

**Option 1 Pay in Full (All Offences)**

If your full payment is received within 28 days, the infringement will be finalised and no further prosecution or enforcement action will be taken against you. Your payment may be made by returning this notice with the full amount to one of the addresses shown at the bottom of this page.

OR

**Option 2 Apply to pay by instalments (offences of \$200.00 and over)**

If this notice has a fine of \$200.00 or more, you may apply to pay by instalments of \$60.00 per month. If your application is received within 28 days, and you make all monthly payments, this infringement will be finalised and no further prosecution or enforcement action will be taken against you. Your application may be made by providing your current address, contact phone number and your first \$60.00 payment to one of the addresses shown at the bottom of this notice.

After making this application, an instalment will be sent to you by the State Penalties Enforcement Registry (SPER). Failure to comply with the instalment plan will result in enforcement by SPER and you will be required to pay additional fees.

If your election for a Court hearing is received within 28 days, a prosecution against you may be commenced in a Magistrates Court. Your election may be made by completing this section and returning this notice to one of the addresses shown at the bottom of the page.
